## Application

1. Complete this form and mail with your check to: Newton Community Farm, Inc., 303 Nahanton St. Newton, MA 02459. Please make checks payable to **Newton Community Farm, Inc.** All CSA sharers receive our monthly email newsletter, *Newton Farmer*, during April through October.

### \_\_\_\_\_ **Weekly Share:**

\_\_\_\_\_ Full payment option: \$640/share, due with application.

\_\_\_\_\_ Split-payment option: \$320/share due with application. Second payment of \$320 due by June 2nd.

\_\_\_\_\_ **Alternate Week Share:** \$345/share, due with application. *Please CAREFULLY select which week you would prefer for your first pickup. Assignment is made on a first-come-first-served basis with half assigned to each week.* Circle one: **June 6<sup>th</sup> -OR- June 13<sup>th</sup>**

2. **Each applicant must be a current Friend of the Farm (FOF).** The program runs on a calendar year basis and is \$45 for individuals or \$70 for families. A link to the FOF form is on the home page of NCF's website. Please send a *separate* check for a non-refundable FOF payment. Not sure if you are currently enrolled in the FOF program? You have been automatically enrolled/renewed if you made a donation in the above amounts or more since our Fall Appeal letter went out in November, 2017.

## Work Commitment

I understand that I am expected to provide a minimum of 10-hours of work for a Weekly Share; 5-hours for an Alternate Week Share. I understand I will be billed \$10/hr for hours not worked **by October 31, 2018. (Initial)** \_\_\_\_\_
